

Integrity notice

Data privacy is important to Antalys and we want to be open and transparent with our handling of your personal data. We therefore have a policy that determines how your personal data must be processed and protected.

Who is the data controller for your personal data?

The Swedish company, Antalys AB, is the data controller for the personal data that you send to us and is responsible for your personal data in accordance with current data protection regulations.

Where do we store your data?

The information we collect from you is stored in our systems; Wordpress, Creatio and our CRM system Pivotal in EU.

Who has access to your data?

Your data can be shared within Antalys AB. We never forward, sell or exchange your data for marketing purposes to third parties outside Antalys AB. If you are a customer of Antalys and have a product/service that we pass on to one of our external partners, they can have access to contact details so that they can provide you with support on the product/service.

On what legal basis is the data processed?

- If you are an interested party (Lead or Prospect) for the purchase of Antalys' services or products, your personal data is stored with the Legal Basis of Balance of Interest
- If you are a contact person for a company that is a customer of Antalys, your personal data is stored with Agreement as the legal basis
- If you are a contact person for a company that is a supplier or partner to Antalys, your personal data is stored with Agreement as the legal basis
- If you are employed by Antalys, your personal data is stored with Agreement as the legal basis

What are your rights?

Right of access:

You have the right to request information about the personal data we hold about you at any time. You can contact Antalys AB, which will send you your personal data via e-mail.

Right to data portability:

Every time Antalys processes your personal data in an automated way after your consent or according to an agreement, you have the right to have a copy of your data in a structured, common and machine-readable format transferred to you or another party. It only includes the personal data you have shared with us.

Right to rectification:

You have the right to request correction of your personal data if it is incorrect, including the right to supplement incomplete personal data.

Right to erasure:

If you are no longer the contact person for a company that is a customer, supplier or interested party, you have the right to contact us and ask us to delete all personal data processed by Antalys AB, with the exception of the following situations.

- You have an ongoing case with Antalys Support.
- You participate or have participated in an ongoing project or other activity with Antalys.
- You are suspected of having or have misused our services or products
- There is another legal basis for retaining the information.

Your right to refuse the processing of personal data due to a legitimate interest:

You have the right to refuse processing of your personal data based on Antalys' legitimate interest. Antalys will not continue to process the personal data unless we can demonstrate a legitimate reason for the process that takes precedence over your interests and rights or due to legal claims.

Your right to refuse direct marketing:

You have the right to refuse direct marketing, including profile analysis carried out for direct marketing purposes. You can opt out of direct marketing in the following ways:

- · Follow the instructions in each marketing mailing
- Contact us at <u>www.antalys.se/contact</u> and let us know you don't want to receive any marketing.

Right to restriction:

You have the right to demand that Antalys restricts the handling of your personal data under the following circumstances:

- If you object to the processing of your personal data based on Antalys' legitimate interest, Antalys shall limit all processing of the data during the ongoing investigation of legitimate interest.
- If you have claimed that your personal data is incorrect, Antalys must limit all processing of this data pending investigation of whether the personal data is correct.
- If the processing of the personal data is against the law, you can object to the deletion of the personal data and instead request restriction of the use of your personal data

Right to lodge a complaint with a supervisory authority:

If you believe that Antalys processes your personal data in an incorrect manner, you can contact us. You also have the right to lodge a complaint with a supervisory authority.
